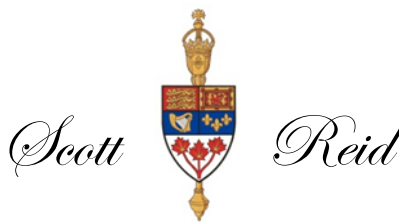

Pursuant to my obligations under Subsection 12 of *the Conflict of Interest Code for Members of the House of Commons* relating to my private interest in matters relating to grocery pricing and Giant Tiger Stores Ltd., and advice I received on June 20, 2024, I am writing to inform you of my brief presence in the House of Commons in the evening of June 3, 2024, at the beginning of consideration of Motion No. 57, *Concurrence in the 19th report of the Standing Committee on Finance, presented on Monday, May 6, 2024 (Excess profit tax on Large Grocery Companies)*.
